We would like to remind you of the following programs and services available to you and your families:

Inkblot – Virtual Mental Health Counselling Services

Inkblot is a provider of video counselling delivered on a secure and encrypted platform. This access is online or the mobile app with the ability to select from a short list of best-matched counsellors (i.e. social worker, psychotherapist, psychologist) based on your unique needs and preferences. You may submit claims for specific counsellors eligible under paramedical practitioners under the RWAM group benefits program. Inkblot counselling fees are competitive amongst other mental health clinics, which would allow your annual maximum eligible under the Equitable policy to stretch further.

Preferred Pharmacy Provider Arrangement

Costco

We wanted to remind you that you have access to a preferred pharmacy dispensing fee arrangement through Costco. Should you choose to fill your prescription at a Costco location; the prescription drug reimbursement will be increased from 80% to 90%. In addition, most Costco pharmacies charge a dispensing fee of less than \$5.00 (compared to \$9.99 to \$12.99 charged by other large pharmacy chains), therefore reducing the out-of-pocket cost to you for this portion of your drug expenses.

Please be advised that you do not have to be a Costco member to utilize their pharmacies and the increased reimbursement rate will be applied automatically at the point of purchase. Costco also offers home delivery services in the province of Ontario.

Through the Loblaw network, you and your eligible family members will have access to preferred pricing on prescription drugs and eyewear, as well as to several general health and nutrition programs and clinical support services for those dealing with specific health conditions.

COSA Eye Care Coverage

COSA recently made changes to their eye care coverage. Coverage will now be up to \$500 per family every 24 months for Paying Members and Grooms on the benefit plan. This will be paid directly by COSA so you will not be able to use your RWAM benefit card to purchase eye care. The RWAM benefit plan covers 120 days out of country travel coverage.
